

**LEGENDS FOR LIGHTS PHEASANT JAMBOREE  
LIABILITY WAIVER, RELEASE AND COVENANT NOT TO SUE  
& EMERGENCY CONTACT INFORMATION**

In consideration of my participation in the Legend for Lights Pheasant Jamboree Hunt, scheduled for October 6,7,8, and 9, 2011, I, on my own behalf, and on behalf of my heirs, representatives, administrators and assigns, hereby waive and release any and all claims, demands, causes of action, suits and rights I or anyone acting on my behalf might have against the Northern Lights Athletic Foundation, its employees, officers and/or directors, or any landowner upon whose lands I am allowed to hunt, for any accident, illness, personal injury (including death), loss of or damage to my personal property, which I (or anyone claiming by or through me) may have against the Northern Lights Athletic Foundation, its employees, officers and /or directors, or any landowner upon whose participation in any activities scheduled for the Legend for Lights Pheasant Jamboree.

Further, I agree that I will not, nor will anyone acting on my behalf or claiming by or through me, bring or maintain any suit in court to assert any claim against the Northern Lights Athletic Foundation, its employees, officers and/or directors, or any landowner upon whose lands I am allowed to hunt, for any claim that I might have arising out of my participation in any activities sponsored by sanctioned by or approved by the Northern Lights Athletic Foundation, its employees, officers and/or directors.

**WARNING:** There are significant elements of risk in any sport or activity associated with any outdoor activity including hunting and the use of firearms and equipment. I realize these elements of risk cannot be eliminated in a wilderness environment. Some of these elements include, but are not limited to, hiking in rugged country, encounters with wildlife, animals and insects, temperature extremes, inclement weather conditions, the unavailability of medical attention while in the wilderness, and the inherent risks of handling firearms and being near others that have firearms in their possession. I understand the risks, hazards and dangers described above and I hereby voluntarily assume and accept those risks.

To the best of my knowledge I have no physical restrictions which would prohibit my participation in any and all scheduled activities offered by the Legends for Lights Pheasant Jamboree.

I am over 18 years of age. I certify that I have all of the necessary licenses and/or permits necessary to participate in any of the Legends for Lights Pheasant Jamboree scheduled activities, and I do not hold Northern Lights Athletic Foundation responsible for any lack of licenses and/or permits.

I recognize Northern Lights Athletic Foundation, its employees, officers and/or directors are not obligated to permit me to participate in any of the Legend for Lights Pheasant Jamboree activities and may terminate my participation in such activities at any time for any reason.

I have read and understand the foregoing provision of this Liability Waiver, Release and Covenant Not to Sue and I have executed this instrument voluntarily on this date.
